a) Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his qualification/ date of birth / reserve category certificates from the concerned issuing authorities is found fake/ forged, his



appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be follow ipso-facto.
