On the recommendations of Service Selection Board received through Administrative Department, sanction is hereby accorded to the temporary appointment of **Shri Jagandeep Singh** as Motor Vehicle Inspector **(EWS Category, Divisional Cadre Jammu)** in the Motor Vehicles Department, J&K in the Pay Level 6D (35800-113200).

The appointee shall report to the office of **RTO**, **Jammu** within a period of twenty one (21) days from the date of issuance of this order failing which, he shall forego his right to temporary appointment, and the same shall be deemed to have been cancelled **ab- initio** without any further Notice as per the instructions issued by General Administration Department vide **Circular No. 08-Jk (GAD) of 2019 dated 04-12-2019.** 

The appointee shall be allowed to join only on the production of the following certificates/documents (in original) to be verified subsequently with the particulars and as per conditions mentioned in letter no. JKSSB-Scry/2023-03 (E-7164134) dated 28/06/2023 and TRPT-MVD0N/43/2023-02-TPT dated 06/07/2023 (Copies enclosed)

- i. Academic/ Technical Qualification Certificates.
- ii. Matriculation / Date of Birth Certificate.
- iii. Health Certificate issued by the Competent Authority.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Affidavit to the effect that he has not taken loan for Self Employment from DIC/ Employment Department.
- vi. Reserved Category Certificate, If any.

The temporary appointment of the above candidate shall also be subject to the following conditions:

- 1. The appointee shall be on probation for a period of two years in the first instance.
- 2. The appointee shall submit an undertaking in shape of affidavit duly attested by a first class Judicial Magistrate to the effect that:

My

- i. In case the character and antecedents received from Police / CID J&K is withdrawn by the concerned Authority, the candidate shall have no right to claim his appointment and his appointment as such shall be deemed to have been cancelled ab-initio;
- ii. In case, if on verification, any certificate produced by the appointees viz. Academic/Technical Certificate/ Driving License, Matriculation / Date of Birth Certificate, Domicile Certificate, Reserved Category Certificate (if any), are proved to be fake, forged or tempered, the provisional appointment shall be cancelled ab- initio. In that event the candidate shall also not be entitled to any salary/wages for the period for which they might have worked in the department.

3. The salary of the appointee shall be drawn and disbursed only after verification and genuineness of other certificates including driving licence from the verifying agencies and

- 4. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- 5. The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as notified vide SRO-400 of 2009 dated 24/12/2009.

6. The appointment shall be subject to outcome of writ petition(s), if any, pending before Competent Court of Law.
