On the recommendations of Service Selection Board received through Administrative Department, sanction is hereby accorded to the temporary appointment of Shri Amit Dhar as Motor Vehicle Inspector (OM Category, under Hon'ble Prime Ministers Special Package) in the Pay Band of Pay Level - 6D (35800-113200) in Motor Vehicles Department:

The appointee shall report to the office of Assistant Regional Transport Officer, Budgam within a period of (21) days from the date of issuance of this order and failing which his appointment shall deemed to have to been cancelled ab-initio without any further notice as per the instructions issued by the General Administration Department.

His joining shall become effective only after he executes an agreement in the "Form" prescribed under Jammu and Kashmir, Migrants (Special Drives) Recruitment Rules 2009 issued under notification, SRO No. 412 of 2009 dated 30.12.2009, besides production of following documents in original.

- I. Academic/technical/Qualification Certificates
- II. Matriculation/Date of Birth Certificate
- III. Health Certificate from the concerned Chief Medical Officer
- IV. Domicile Certificate (PRC) issued by the Competent Authority
- V. Valid relevant Category Certificate, if any, applicable
- VI. Migration Certificate of being a Kashmiri Migrant duly issued by Relief and Rehabilitation Commissioner (Migrant).

## The temporary appointment of the above selected candidate shall further be subject to the following conditions: -

- a. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his qualification/ date of birth / reserve category certificates from the concerned issuing authorities is found fake/ forged, his appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be follow ipso-facto.
- b. That if the candidate has taken loan for Self-Employment from DIC/ Employment Department to be ascertained from the District Industry Centre (DIC) and District Employment & Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if

any, in such employment unit/ enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIS to be worked out by the DDO concerned from his salary. DDO concerned shall regarding both appointee from concerned the affidavit an obtain relinquishment of proprietorship and stakes, if any, in such unit/enterprise and recovery to be made and also personally monitor its recovery.

The salary of the appointees shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/date of Birth/Relevant category certificates / Technical Qualification is received from the concerned Authorities/Agency.

- c. The appointee shall have to work in the respective District/ Division of appointment in the Kashmir Valley and shall not be eligible for transfer outside the District/Division under any circumstances In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his/her migration, in terms of the agreement executed by each appointee under SRO-412.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.

f. The appointment of the selected candidate shall be subject to the outcome of writ petition(s), if any, pending before Competent Court of law.
